### SUPPLEMENTAL DECLARATION OF ERIC A. NORDSKOG REGARDING: (A) MAILING OF THE POSTCARD NOTICE; AND (B) REPORT ON REQUESTS FOR EXCLUSION AND OBJECTIONS

I, Eric A. Nordskog, declare as follows:

1. I am a Senior Project Manager of A.B. Data, Ltd.'s Class Action Administration Division ("A.B. Data"), whose Corporate Office is located in Milwaukee, Wisconsin.<sup>1</sup> Pursuant to the Court's May 2, 2023, Order Granting Preliminary Approval Pursuant to Fed. R. Civ. P. 23(e)(1) and Permitting Notice to the Settlement Class (the "Notice Order"), A.B. Data was authorized to act as the Claims Administrator in connection with the Settlement in the abovecaptioned action. I am over 21 years of age and am not a party to this action. I have personal knowledge of the facts set forth herein and, if called as a witness, could and would testify competently thereto.

2. I submit this Declaration to supplement my Declaration Regarding: (A) Mailing of the Postcard Notice; (B) Publication of the Summary Notice; and (C) Report on Requests for Exclusion and Objections dated July 5, 2023 (the "Initial Mailing Declaration"), which was previously filed with the Court (ECF 236-1).

#### **UPDATE ON MAILING OF THE NOTICE AND PROOF OF CLAIM FORM**

3. As more fully stated in my Initial Mailing Declaration, as of July 5, 2023, A.B. Data had mailed a total of 524,864 copies of the Postcard Notice to potential Settlement Class Members and nominees.

4. Since my Initial Mailing Declaration was executed, and as of the date of this Declaration, A.B. Data has caused an additional 57,663 Postcard Notices to be mailed in response to correspondence received from potential Settlement Class Members and nominees.

#### **UPDATE ON TELEPHONE HOTLINE AND WEBSITE**

5. On or about May 23, 2023, a case-specific toll-free phone number, 866-963-9979, was established with an Interactive Voice Response system and live operators. An automated attendant answers all calls initially and presents callers with a series of choices to respond to basic questions. If callers need further help, they have the option to be transferred to an operator during business hours. As of the date of this Declaration, A.B. Data has received 1,718 telephone calls. A.B. Data has promptly responded to, and will continue to promptly respond to, all inquiries to the toll-free number.

6. On or about May 23, 2023, A.B. Data has also established a case-specific website, <u>www.ArconicSecuritiesSettlement.com</u>, which provides general information regarding the case and its current status; downloadable copies of the Long-Form Notice, Proof of Claim and Release, and other court documents, including the Stipulation; and online claim submission capability. The settlement website is accessible 24 hours a day, 7 days a week. As of the date of this Declaration, the settlement website has been visited at least 52,134 times.

#### **UPDATE ON REQUESTS FOR EXCLUSION AND OBJECTIONS**

7. The Postcard Notice directed potential Settlement Class Members to the Long-Form Notice for instructions on how to request exclusion from the Settlement Class or object to the Settlement. Written requests for exclusion were to be mailed to *Arconic Securities Settlement*, EXCLUSIONS, c/o A.B. Data, Ltd., P.O. Box 173001, Milwaukee, WI 53217 such that they were received no later than July 19, 2023. A.B. Data has been monitoring all mail delivered to the post office box. As of the date of this Declaration, A.B. Data has received two (2) requests for exclusion. Attached to this Declaration as Exhibit A is a listing of the exclusion requests received and redacted copies of the requests.

Settlement Class Members seeking to object to the Settlement, the proposed Plan of Allocation of the Net Settlement Fund, and/or Lead Counsel's Fee and Expense Application are required to submit their objection in writing such that the request is received by the Parties and filed with the Court no later than July 19, 2023. As of the date of this Declaration, A.B. Data has not received any objections.


